### INFORMATION about the presented financial data.

#### 1. Balance Sheet

Balance sheet shows Facilite receives its donations only by Bank. Money that has not to be spent in the coming month will be put on its secure savings account, before it will be transferred to the field activities in the Facilite mission in Congo, Nepal, Ivory Coast.

At the year end we had to receive still 8,000 Euro from a gratefully promised grand. Current liabilities include some short time loan and a credit from Christian relations on soft terms, no interest, or fixed term of repayment. But even a possibility of rebranding as grand.

### 2. Donations

We have a small group of individual Christians and several Churches who are very dedicated in supporting the activities in our mission fields. For special needs, like Children's Bibles, we work with interested Foundations.

#### 3. Breakdown of Expenses 2022

It shows that 97,5 % of the funds received goes into mission. We only spend a fraction (1,1 %) on fundraising. In 2022 most of the installed travel restrictions due to 'corona' were lifted. All missions had to be visited as much as possible. But airplane ticket prices had risen substantially, which resulted in this high travel expense for Rev. Abram Krol.

#### 4. Expenses

We could spend some 20 % less on the regular Missions in Congo, Ivory Coast and Nepal. So we were able to expand the mission activities into Liberia and Guinee on a low key basis. As we do not want to overstretch our financial capabilities. Even when we are always astonished the Lord will provide in the end.

The focus of Facilite is always on the more or most poor regions of a country. These people cannot afford to buy a Bible. They sometimes have only ONE Bible for the whole Church.

We were most grateful to do a special Project in distributing bilingual Children's Bible, mostly covered by a grand.

#### 5. Accountability

As Christians we realize that we have to maintain the highest form of accountability. So all board members are always in advance informed of the necessity and the amount of every payment to one of the missions. After every mission trip, Rev. Abram Krol gives a detailed written review of the activities and the expenses that had to be made.

#### 6. Board members

None of the board members of Foundation Facilite is on the payroll of the foundation. Only travel expenses can be declared. They all have other jobs, or are retirees who enjoy their retirement income.
